## CONTRACT FOR PROJECT MANAGEMENT SERVICES CONTRACT #SCH-19-C-001 AMENDMENT NO. 5

**WHEREAS**, the Westwood Public School District acting on of behalf of the Town of Westwood ("Owner") and Compass Project Management, Inc., (the "Owner's Project Manager") (collectively, the "Parties") entered into a Contract for Project Management Services for the Hanlon Elementary School Project on May 7, 2019 "Contract"; and

**WHEREAS**, effective as of December 3rd, 2021, the Parties wish to amend the Contract, as amended:

**NOW, THEREFORE**, in consideration of the promises and the mutual covenants contained in this Amendment, and other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

- A. Add the service of the Owner's Project Manager (OPM) from Construction Document Phase service at \$28,000 per month for six (6) months from November 2021 to May 2022 for a total of \$168,000 for Construction Document Phase.
- B. Add the Estimating service associated for 60% CD and 90% CD for \$60,000.
- C. Add the service of the OPM for Bidding Phase at \$25,000 per month for the month of May and June of 2022 totaling \$50,000 for Bidding Phase.
- D. Add the service of the OPM including Construction Site Manager during the first twenty-four (24) months of construction for the new school building and site except existing school area. The fee will be \$56,000 a month for twenty-four (24) months for a total of \$1,344,000 for the first part of the Construction I Phase.
- E. Add the service of OPM for the demolition of existing school and the associated site work including a part time Construction Site Manager. The fee will be \$32,845 a month for six (6) months for a total of \$197,070 for the second part of the Construction II Phase.
- F. Add the service of OPM for the Close Out Phase of the project at \$6,000 per month for eleven (11) months for total of \$66,000 for this phase.

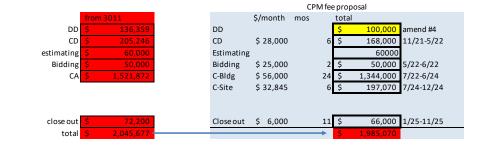
