Since 9/14, **486** (last report: October = 133, November = 320) students have been supported by the COVID team and been absent from in-person instruction. Approx. 16% of the student population.


**454** students (last report: October = 103, November = 271) have been cleared to return to in-person learning.

**32** (last report: October = 30, November = 49) students continue to learn remotely due to being quarantined due to travel, being a close contact or illness.

There have been **26** (last report: October = 1, November = 14) positive student cases identified.

# **Staff Data**

Since 8/31,**166** (last report: October = 59, November = 106) staff have been supported by the COVID team and been absent from in-person work. Of our 622 staff, 26% impacted.

**152** (last report: October = 39, November = 96) have been cleared to return to in-person work.

# Staff data

**14** (last report: October = 20, November = 10) staff continue to work remotely due to being quarantined due to travel, being a close contact or illness.

There have been **17** (last report: October = 2, November = 6) positive staff cases identified.

#### Consultation

The three members of the Covid Team have consulted with **300** (last report: October = 89, November = 221) **parents and staff** since 8/31 to answer questions related to protocols, travel, symptoms, next steps, etc.
