SCHOOL START TIMES SUBCOMMITTEE MEETING MINUTES December 1, 2021

Attendance and Call to Order

The meeting, held remotely¹, was called to order at 3:32pm by Subcommittee Chair Anthony Mullin. Subcommittee Chair Update

Welcome and Introductions

Members of the Subcommittee introduced themselves.

Discussion Items

Research Overview

Two pieces of research were shared; one included a summarization of existing research; the other an article from National Public Radio. There is broad research that has examined secondary schools' start times.

Superintendent Parks stated that the district has been thinking of changing school start times for a number of years. She presented this topic to the School Committee during the 2015-2016 school year. Work on the change was disrupted by the pandemic.

She further shared that the work of the Subcommittee is aligned with the district's strategic priority of a healthy and supported school community.

Group Objective and High-Level Project Plan

Subcommittee Chair Mullin shared the work plan:

- Form Subcommittee and kickoff—December 2021
- Develop list of potential options and survey design—January 2022
- Community forum on the science of school start times—January/February 2022
- Conduct teacher/staff, parent, and student surveys—Late January/early February 2022
- Understand impacts of different options—February/March 2022
- Develop criteria for evaluating options—February 2022
- Review survey results—March 2022
- Assess options / conduct analysis based upon criteria and community input—March/April 2022
- Update to School Committee—April 2022
- Community forum on start time options—*April/May* 2022
- Recommendation to School Committee—May/June 2022

- Implementation planning—June 2022-June 2023
- Planned implementation of new start times—Fall 2023

Brainstorm on Key Implementation Challenges

The Subcommittee brainstormed some key implementation challenges, which included:

- Transportation
- Before and After School programming
- Athletics
- Students with after-school jobs
- Start times of clubs and impact on advisor availability
- Community use of facilities/building rentals
- Use of early morning time
- Lunch scheduling
- Custodial shifts

Superintendent Parks and Director of Business and Finance Lemma Jn-baptiste will analyze challenges related to transportation and present to the Subcommittee at the next meeting.

Subcommittee Chair Mullin will share examples of surveys with the group. He requested that members review ahead of the next meeting.

Future Meeting Schedules

It was determined that monthly meetings between January and June be scheduled at 3:30pm.
