RE: Proposed Policy IKFE: Competency Determination

In addition to local graduation requirements, Massachusetts state law requires students to satisfy the requirements of the Competency Determination (CD) to graduate from high school. Although MCAS had been used as the primary measure for students to achieve the CD, when Massachusetts voters approved Ballot Question 2 in November 2024, MCAS was no longer able to be used as the sole basis for students to meet the competency determination requirement.

In May 2025, the state Board of Elementary and Secondary Education voted to amend its regulations on the Competency Determination, and in doing so, required districts to adopt a competency determination policy. To support this policy development, DESE released guidance in July 2025 and the Massachusetts Association of School Committees released their policy template in August 2025.

The new competency determination regulations require that students must show two things: a mastery of skills in English Language Arts, Mathematics, and Science; and the satisfactory completion of relevant coursework aligned to the standards in those areas. For students in the Class of 2027 and beyond, the regulations also extend to mastery and coursework in United States History.

Our proposed policy addresses the CD by requirement by identifying which courses in the Westwood High School Program of Studies meet the coursework requirements, and by articulating our process for students demonstrating mastery through their performance on summative assessments in each content area. As it was important to provide multiple pathways for students to demonstrate mastery, the proposed policy also includes a provision for a portfolio review of student assessments in lieu of a purely mathematical average of scores.

POLICY IKFE - COMPETENCY DETERMINATION

One of the requirements for graduation in Massachusetts is a determination of competency in subjects previously covered by the MCAS. In addition to other requirements for graduation, students must have been determined by the district to have achieved mastery of the common core of skills, competency, and knowledge in said areas, and satisfactorily completed coursework that has been certified by the student's district as showing mastery of the skills, competencies, and knowledge contained in the state academic standards and curriculum frameworks.

Competency Determination Requirements

A determination of competency shall include:

- Demonstrating a mastery of skills in English Language Arts, Mathematics, and Science; and the satisfactory completion of relevant coursework aligned to the standards measured by the high school English Language Arts, Mathematics, and Science MCAS assessments administered in 2023.
- An additional requirement for mastery in US History will apply to the graduating Class of 2027, and beyond.

To show mastery, a student must successfully complete, in accordance with the district's grading policy or by any other appropriate methodology as may be determined by the School Committee:

- 1. The final assessment for a course; or
- 2. A capstone or portfolio project; or
- 3. An equivalent measure identified in the district's CD policy.

A student enrolled in the Westwood Public Schools will be determined to have satisfactorily completed coursework and earned full credit in accordance with the district's grading policy and the requirements outlined below:

Additional Considerations

Students with Disabilities

The Westwood Public Schools must both provide a Free and Appropriate Public Education to students with disabilities and must also determine that the student has met the competency determination and local graduation requirements prior to graduating that student. Students with disabilities who have been placed in out-of-district placements must meet the requirements of the competency determination policy of the placing school district. Discussion of the competency determination must be part of the IEP Team's transition planning.

English Language Learners

The Westwood Public School District shall, on a case-by-case basis, determine appropriate courses necessary for English Language Learners to both achieve language proficiency and meet the competency determination requirements.

Late-Enrolling Students

Students who enroll in a Massachusetts public high school after their ninth-grade year may be granted a determination of competency by the Westwood Public Schools in one or more of the following ways:

- Transcript Review by School Counselor and Building Administrator
- Additional course requirements as determined by School Counselor and Building Administrator
- Meeting the standard for a substituted equivalent that the district certifies satisfies the same academic standards
- In cases where WPS is unable to verify a student's prior coursework through transcripts
 or internal records, a qualifying MCAS score in the relevant subject may be used to
 meet the CD requirement. This will be used only in exceptional circumstances and will
 be subject to internal review.

<u>Current or Former Students not earning their competency determination may participate in the following Appeals Process:</u>

 Students enrolled in the Westwood Public Schools in the Classes of 2003 through 2024 who did not earn a diploma due to not passing the MCAS may appeal the decision and request a transcript review to determine if they have met the competency determination requirement.

•	Students enrolled in the Westwood Public Schools in the Class of 2025 and beyond may appeal the competency determination by participating in a transcript and portfolio review to determine if they have met the competency determination requirement.
