SCHOOL START TIMES SUBCOMMITTEE MEETING MINUTES January 26, 2022

Discussion Items

Orientation to District Transportation

Superintendent Parks and Director of Business and Finance Lemma Jn-baptiste reported that transportation is a major driver in determining school start times and a consultant may need to be considered to assist in the project.

The current yellow bus contract specifies how many buses are used for the year. The district currently contracts for seventeen buses. Each bus costs approximately \$72k per year.

There are legal and School Committee policy requirements related to student transportation. The policy is greater than what is required by law.

School Committee Policy: All kindergarten and grade 1 students are eligible for bus transportation no matter where in town they reside. Students in grades 2 through 5 are eligible if they reside more than one mile from school. In grades 6-12, students residing more than 1-1/2 miles from school are eligible.

Law: Public schools do not have to provide transportation for students in grades 7-12.

Another impact on bus transportation is those that reside within the walker zone. Families are able to apply for bus transportation and, if there is room, the district will accommodate. There are times, however, when applications do have to be rejected.

Current data on bus riders and routes was reviewed.

The Subcommittee discussed, but made no final determination on, the acceptable length for a bus run. They also discussed methods to more tightly draft bus routes, including no longer permitting walker zone students to ride; and monitoring the actual time needed to complete each run while having students arrive to school on time.

Marian Donovan noted that Xaverian Brothers High School's arrival and dismissal impacts travel times.

Subcommittee Chair Mullin would like data on bus utilization: how many students register versus how many actually ride the bus.

High-Level Draft of Potential Start Time Schedule

High School Principal Amy Davenport and Middle School Principal Michael Redmon were asked to review the bell schedules for their schools and to propose scenarios for start times at 8:00am, 8:30am, and 9:00am. These scenarios were shared with the Subcommittee.

The Subcommittee discussed the earliest reasonable and tolerable start time for elementary school students. Concerns regarding having elementary students waiting for the bus in the dark were expressed.

The Subcommittee also discussed the impact to Boston resident students.

If the district were to pivot to an earlier start time at the elementary schools, there would likely be an increased enrollment for the Extended Day Program.

Community Surveys

Subcommittee Chair Mullin shared surveys from Newton, Norwood, and Winchester that were conducted with staff/teachers, parents, and students.
