SCHOOL START TIMES SUBCOMMITTEE MEETING MINUTES April 13, 2022

Attendance and Call to Order

The meeting, held both in the Westwood Public Schools District Administration Office Professional Development Room, and remotely¹, was called to order at 3:31pm by Subcommittee Chair Anthony Mullin in-person.

Discussion Items

Feedback from Parent Forum on Adolescent Sleep

The Subcommittee was pleased with the forum and agreed that Dr. Owens' presentation was compelling.

<u>Initial Responses to Community School Start Times Surveys</u>

Director of Business and Finance Lemma In-baptiste shared resulting survey data to-date.

Parents' Survey

- Total number of responses: 399
- Number of respondents with a child in High School in 2023-2024: 203
- Number of respondents with a child in Middle School in 2023-2024: 173
- Number of respondents with a child in an elementary school in 2023-2024: 169

When asked which positive impacts of starting the middle or high school later made the most sense, the top three responses were:

- Allow students to sleep later
- Help students focus more during the school day
- Improve students' mood during the school day

When asked which negative impacts of starting the middle or high school later made the most sense, the top three responses were:

- Starting after-school commitments (including sports) later
- Less free time in the afternoon
- Having to stay up later to get everything done

When asked about impacts to routines on specific start times, the majority responses noted:

- High School starting at 8:10am Very positive
- High School starting at 9:00am Very positive
- High School dismissing at 2:50pm Very positive and neutral
- High School dismissing at 3:40pm Neutral, very negative, and somewhat negative
- Middle School starting at 8:30am Very positive
- Middle School starting at 9:00am Very negative and somewhat negative
- Middle School dismissing at 3:07pm Very positive and neutral
- Middle School dismissing at 3:37pm Neutral and very positive
- Elementary Schools starting at 8:00am Somewhat negative and neutral
- Elementary Schools dismissing at 2:20pm Neutral

When asked whether a later start time would increase or decrease the need for school bus transportation:

- High School Would not make a difference
- Middle School Would not make a difference
- Elementary Schools Would not make a difference

When asked whether a later start time would increase or decrease the need for a parent to provide transportation:

- High School Would not make a difference
- Middle School Would not make a difference
- Elementary Schools Would not make a difference

If the elementary schools moved to an earlier start time, the majority indicated that they would not need to enroll their children in the Before School Program. However, the majority would need to enroll in the After-School Program.

There are approximately 1,750 families in the district, which calculates a response rate of 23%. School principals will communicate with their families asking them to respond.

The Subcommittee expressed concern about the challenge in scheduling secondary schools' sporting events and activities if there is a later school start time.

Response data from staff was shared with the Subcommittee.

Criteria to Use for Evaluating Options

The Subcommittee brainstormed criteria to use for evaluating options, which included:

- Ensuring the shift is large enough for students to increase sleep
- Bandwidth to absorb the change
- Cost of bus transportation
- Impact to athletics
- Number of hours students are at the Extended Day Program, and the resulting cost impact to families
- Capacity of the Extended Day Program to provide service to families
- Schedule alignment between middle and high schools

<u>Update on Traffic Study and Transportation Logistics</u>

Three proposals from different firms have been received. Two are strong. Director of Business and Finance Lemma Jn-baptiste will be following-up with vendors to finalize a timeframe. However, with only six weeks to conduct a high-level analysis before June's School Committee meeting, a smaller study may only be able to be conducted.

Data on high school bus ridership is being collected.

Timing of Next Forum

An interactive parent forum will be scheduled soon.
